

WHAT IS PTAC?

The Procurement Technical Assistance Center (PTAC) is a **no-cost service** of the Northeastern Pennsylvania Alliance (NEPA) that provides expert assistance to northeastern Pennsylvania businesses in all aspects of government contracting.

Funding by the Department of Defense allows the PTAC to provide counseling, training workshops, seminars and many valuable resources that will help win contracts with federal, state and local governments.

WHY CONTRACT WITH THE GOVERNMENT?

- The government is the largest buyer in the U.S.
- The government purchases and needs various types of products
- The government buys over \$650 billion annually
- The government can be a reliable, continuous source of business

BIDDING ON GOVERNMENT CONTRACTS

The first step in becoming a federal contractor is to contact the NEPA PTAC and make an appointment. Companies should be prepared to learn new terms about the government purchasing process. The NEPA PTAC will identify opportunities and provide up to date information to advance a business to the next level in the government contracting process.

WHAT NEPA'S PTAC CAN DO FOR YOU?

The NEPA PTAC offers several services that can help effectively compete for and win government contracts. The key to winning a contract is effective marketing and knowing the customer.

The NEPA PTAC can provide market research that makes it easier to target those agencies that purchase specific product or service.

The NEPA PTAC experts guide clients through the government purchasing process. Counseling services are available by appointment and seminars are held throughout the year.

WHAT STEPS TO TAKE?

- Have a viable product or service
- Register on-line with the appropriate government agencies that purchase the product/service
- Determine if any certifications are applicable
 - *Woman Business Enterprises (WBE) State certification for woman owned small businesses*
 - *Minority Business Enterprise (MBE) State certification for minority owned small businesses*
 - *Small Disadvantaged Business (SDB) Federal certification for small businesses that can demonstrate an economic or social disadvantage*
 - *Historically Under Utilized Business Zone (HUBZONE) Federal certification for small businesses located in economically distressed areas*
- Market the products/services to government agencies by identifying specific agencies that show interest
- Establish a rapport with the purchasers at government agencies
